President Biden and Congresses' revision to the definition of revenue under the 90/10 Rule contained within the American Rescue Plan is unfortunately just one of many initiatives focused on reforming our community's eligibility to remain a full and equal sector within the higher education community. But as our collective community showed in working with the Senate to develop language which was added in order to provide adequate time for a transition to the new definition...there are things we can and must do to prepare to address them head on.

## **Keynote: Career Education Transformation: the Path Forward**

The entire higher ed/post-secondary ed space is in turmoil. The reality is that the significant decline over the last decade is not slowing down and the entire market will likely be another 20% smaller in ten years, thus about 40% smaller in total since 2010. The fundamentals are getting worse, not better. The future of career colleges will depend on building a completely new model for higher education designed to dramatically increase the likelihood that a given school will be on the side of the ledger of "survive and thrive" rather than become a "zombie" institution or fail outright. This is NOT about improving lead conversion rates or discreet retention plans, etc. This is about TRANSFORMATIONAL change. The reality is that most institutions are simply not ready or capable of doing what is necessary, and many will die slow deaths (over the last 11 years roughly 1,300 failed rather than change), but there is a path to the next normal for those that are up to the challenge.

**Safe House Project - Eliminating Human Trafficking in America, and Other Responsibilities of the Community Career College**

Too long have career schools been institutionally focused, concentrating simply on the employers they serve, the consumers who become their students, and the business unit that is their institution. Employers, students, and institutions may be the three core constituencies of a career school, but when we fail to contextualize our institutions within the communities we serve, we minimize our civic role within the community and, by default, choose not to become a solution to the needs of the community around us. Dr. Joel English will discuss the evolution that Centura College, Aviation Institute of Maintenance, and Tidewater Tech has made over the past six years, focusing on community outreach, student service learning, and a mission toward becoming solutions to the needs of the dozens of communities the schools serve. He will introduce Dr. Kenneth Cooper Alexander, the Mayor of Norfolk, Virginia, and the new Chancellor of the institutions, and discuss how community service has led to a consummation between community and career school. And together, they will introduce Kristi Wells, the CEO of The Safe House Project, a non-profit institution dedicated to eradicating human trafficking and sexual exploitation within the United States. The three will discuss the mission of the Safe House Project and announce how both the City of Norfolk and the Family of Career Schools have committed to training employees, civil servants, students, and community members throughout the country to be aware of the signs of human trafficking through the OnWatch Program. The three presenters will challenge all career schools to become agents of social change within their communities, and they will provide an opportunity for all schools to join the fight against sex trafficking by adopting the OnWatch Program within their own institutions.
